YOUR FEBRUARY 14 - 22, 2025 ITINERARY

FRI., FEB. 14 - DEPARTURE NEW YORK TO ACCRA

Our jet departs in the evening from New York for our journey to Ghana. Dinner and breakfast will be served during the overnight flight. (D,B)

SAT., FEB. 15 - ACCRA

Upon arrival in Accra, Akwaaba, we will be met by our tour representative who will assist us through immigration and customs. We proceed to hotel for check in. Accra is the Capital of Ghana with a population of over 3.5 million people. We will experience Accra's vibrancy through its traffic its lush residential areas for the rich and traditional buildings for the middle income and low income people. As cosmopolitan city you will hear various languages spoken by the residents of Accra. We will proceed to visit the W.E. Du Bois centre for Pan African Culture, the national Museum for collection of prehistoric and contemporary artifacts. Continue to Nkrumah Park for a guided tour into the life and work of the first president of Ghana. Visit the Arts Centre for shopping. Return to your hotel. Overnight in Accra. (D)



SUN., FEB. 16 - ACCRA/KUMASI

After breakfast at our hotel, we drive North to Kumasi, the cultural city of Ghana and the home of the Asantehene the traditional head of the Ashanti. Where you will see lots of people clad in the world famous Kente. Kente cloth is the epitome of culture and pride of the Asantes. Proceed to the craft village of Bonwire the home of the famous kente cloth learn about its origin and the weavers how it passes on from generation to generation. Leave Bonwire to Ntonso for traditional Adinkra cloth where you can also make your own patterns and learn how the back colour of the cloth is made. Continue to Ahiwaa for the Wood Carvings and fertility doll, the famous Ashanti stools for the chiefs and queens. Continue to your hotel for overnight. (B,D)

MON., FEB. 17 - KUMASI

After breakfast, we visit the cultural centre which includes the Prempeh II Jubilee Museum. We drive to the Manhyia Palace, home



of Asantehene, the King of Asantes. In the afternoon we will visit a Coco Farm in a village (Golden Pot) and return to Kumasi for dinner and overnight. (B,D)

TUE., FEB. 18 - KUMASI/HERITAGE TOUR/CAPE COAST

After breakfast, we drive south to visit Kakum National Park which has a variety of medicinal plants. Enjoy a walk on one of the only four canopy walkways in the world and view the various levels of this tropical rain forest. Or trek on the Kenton trail and get to know the medicinal value of the various African tree species. Continue to the Central Region and the Cape Coast which is one of the most historical cities in Ghana. We continue to Elmina Castle (also known as the Castle of St. George), the first European edifice constructed in Africa by the Portuguese in 1482. Elmina Castle was taken over in 1637 by the Dutch who retained control for 274 years. Dinner and overnight in Cape Coast. (B,D)

WED., FEB. 19 - CAPE COAST

After breakfast, we continue our tour of the Cape Coast where most of the oldest and best schools in Ghana are located. This morning we visit Cape Coast Castle through which thousands of slaves were shipped to the Caribbean and the United States. The castle was the seat of British Colonial administration until 1877 when government offices moved to Christianborg Castle in Accra and has been designated by the United Nations as a World Heritage Monument. Dinner and overnight in Cape Coast. (B,D)

THU., FEB. 20 - CAPE COAST/ACCRA

After breakfast, we drive through beautiful countryside as we drive northeast to Accra where we will stop at the Makola market, the largest open air market in the city. Dinner and overnight in Accra. (B,D)



FRI., FEB. 21 - ACCRA

After breakfast, we have a full day at leisure to pursue personal interest, shopping, visit a local church or just enjoy. Dinner and overnight Accra (B,D)

SAT., FEB. 22 - USA

Breakfast at the hotel, we depart for Accra International Airport for departure formalities. We say DAYIE (byebye) to our new found brothers and sisters as we depart for our flight home, taking with us memories of the beautiful land of Africa. (B)

OPTIONAL FEBRUARY 22-25, 2025 SENEGAL TOUR

SAT., FEB. 22 – ACCRA/DAKAR

Transfer to the airport for our flight to Dakar. Upon arrival in Dakar, Senegal we will be met by our tour representative who will assist us through immigration and customs. We proceed to hotel for check in. After check in the guide will give what to expect during your stay in Senegal and Gambia. Dinner and overnight at the hotel in Dakar. (D)

SUN., FEB. 23 - DAKAR/GOREE ISLAND/DAKAR

After breakfast we will start our city tour of Dakar. We will go from Independence Place, the heart of the city, passing by the Presidential Palace and the main Cathedral as continue to seafront drive towards Soumbédioune market and the mosque de la Revelation. We will visit the Renaissance Monument which is 164 feet tall overlooking the city. The once controversial bronze statue is now a very popular attraction. Next we will visit the Museum of African civilization. This massive 4 story complex was based on Senegal's first President Leopold Sedar Senghor. After lunch on our own we will ferry to Goree Island, a UNESCO site. While on the island we will explore the pastel colored colonial buildings. Among the famous buildings here is the House of Slaves which records the history of Goree Islands past. Here we will observe the "Door of No Return" through which millions passed on the way to slavery. Return to Dakar for dinner and overnight. (B,D)

MON., FEB. 24 - DAKAR/ST. LOUIS/LOMPOUL

After breakfast we drive north to St. Louis, Senegal's northern colonial capital. We will explore the narrow streets flanked by houses with wooden balconies. Our tour will take us to the fishing village of Guet Nadar. After lunch on our own we continue to Lompoul in the desert of Senegal. Here we will enjoy a camel ride to the top of the sand dunes with a panoramic view of the coastline. Spend the night in comfortable tents and feel like nomads observing the moon or the stars. Dinner and overnight. (B/D)

TUE., FEB. 25 – LOMPOUL/DAKAR/USA – After breakfast we will depart for Dakar to catch our flight home.

TERMS AND CONDITIONS

Tour prices: All prices in this brochure are based on airfares, land rates and exchange rates in effect at the time of printing and on group rates of 30 passengers or more. Tours may depart with less than the required number of passengers, at the discretion of Group IST, LLC (doing business and referred to therein as "Journeys Unlimited"), but an additional charge may apply. Passengers will be advised about such surcharges 60 days before departure. All prices are subject to change without notice prior to departure due to major currency fluctuations, changes in fuel prices and/or unforeseen economic circumstances.

Reservations, Deposits and Final Payments: Please complete the Participant Agreement, with full names as they appear on passports, and mail it to us with the required per person deposit plus applicable (optional) insurance. Receipt of your deposit shall act as your agreement to these terms and conditions. Balance is due 75 days before departure date. If final payment is received less than 75 days, a late fee will be assessed in the amount of \$50.00. If final payment is made by credit card (American Express, Visa, MasterCard), Journeys Unlimited requires a completed credit card authorization form. All payments made by check should be made payable to Journeys Unlimited.

Late Reservations: If a booking is made within 60 days of departure, full payment plus applicable taxes and optional insurance is due at the time of booking. There will be a \$50.00 late processing fee applicable plus cost of any express or overnight mail services. No personal checks will be accepted with reservations received 30 days or less before departure date. Money order, bank check, certified check or credit cards (American Express, Visa, and MasterCard) will be accepted.

Travel Documents: A valid passport (valid for six months after the return date of the trip) is required to travel. Visa is required for US passport holders traveling to some destinations; please contact our office for details. All non-US citizens must contact the appropriate consular office for entry visa requirements pertaining to their trip. In addition non US citizens are responsible for complying with requirements for re-entry into the USA. Journeys Unlimited assumes no responsibility for procurement of passport or visas. Obtaining and carrying these documents is the sole responsibility of passengers. Journeys Unlimited will not be responsible for any delays, damages and/or losses, including missed portions of your trip due to improper travel documentation.

Final Documents and Tickets: All documents and tickets are only issued upon receipt of final payment and are sent within 3 weeks of departure. Documents and tickets are not guaranteed if final payment and booking form are not received on time.

Air from Home City: All brochure departures are based on a New York area airport. Journeys Unlimited can help arrange air transportation from your home city airport. Journeys Unlimited is not responsible for any penalties incurred on domestic tickets not purchased from us, in case of changes in the schedule of the tour. If you are making your own domestic airline tickets, please make sure that your domestic flight time arrives at least 4 hours prior to your international departure time.

Air Changes, Cancellations & Refunds: Airline tickets issued by Journeys Unlimited are highly restrictive and in most instances cannot be reissued, revalidated or exchanged. If a change is possible, a \$75 per person administrative fee, plus any applicable airline change fees, will be assessed once air tickets have been issued. Airline penalties vary depending on carrier.

Airline Seat Assignments and Special Services: There is no advance seat selection. Early check-in is necessary to secure seats with travel companions. Seating is solely under control of the airlines. Some airfares used may be eligible for frequent flyer mileage.

If a roommate is not available, you must pay the single room supplement. While single rooms provide privacy they are often smaller than twin bedrooms. Triple rooms are available in many hotels for family or friends traveling together. There are no discounts for triple rooms.

Medical Conditions: While we endeavor to provide the highest level of service to all our passengers, we cannot guarantee special facilities or assistance for disabled passengers and it is your responsibility to arrange for such assistance as required.
